SUBJECT: Approve Resolution Number 2024-14 to approve the application for Bicycle and/or Pedestrian Funds Under Transportation Development Act for Fiscal Year 2021, 2022 and 2023.

ISSUE:

Shall the City Council approve Resolution No. 2024-14 authorizing an application for Article 8e Bus Benches/Shelters and Article 3 Bicycle/Pedestrian Projects in the amount of \$36,185.00 Authorize the City Treasurer to sign the applications on behalf of the City?

MANAGER'S RECOMMENDATION:

It is recommended that the City Council approve the resolution authorizing the application of the funds and designate the City Treasurer to act on behalf of the City.

FISCAL IMPACT:

The total amount that will be available to the city is \$36,185.00 for fiscal years 2021, 2022, and 2023. These revenues will be allocated to the Local Transportation Funds.

DISCUSSION

The Local Transportation Fund is available to be spent for the exclusive use by pedestrians and bicycles, including but not limited to: curbs, handicap access ramp projects, sidewalks, pedestrian ways, bikeways, bike racks and bicycle storage.

CONCLUSION

The funds will be used for various improvement projects such as handicap access and sidewalk rehabilitation. In order to receive the money, the City must adopt the Resolution as presented, complete the claim forms and submit to ICTC. Therefore it is recommended that Council take action to adopt Resolution Number 2024-14 and authorize the City Treasurer to sign the necessary documents on behalf of the City.

RESOLUTION NO. 2024-14

A RESOLUTION OF THE CITY OF WESTMORLAND APPROVING THE APPROVING THE APPLICATION FOR BICYCLE AND/OR PEDESTRIAN FUNDS UNDER THE TRANSPORTATION DEVELOPMENT ACT AND APPROVING THE ADOPTION OF ITS BICYCLE AND/OR PEDESTRIAN PLAN FOR FISCAL YEARS 2021, 2022, AND 2023.

Whereas, The Transportation Development Act provides that 2 percent of each county’s total Local Transportation Fund be annually set aside and used to fund the development of bicycle and pedestrian facilities; and

Whereas, the City of Westmorland has planned a bikeway system in conformance with specifications of Caltrans’ *Planning and Design Criteria for Bikeways in California*, and the Regional Transportation Plan; and

Whereas, the City of Westmorland desires to construct this project within their city using the funds available under the Transportation Development Act.

Now Therefore, Be It Resolved by the City Council of the City of Westmorland as follows:

1. To authorize the City Treasurer as the City’s authorized signature and designated contact person;
2. To apply for funds available to the City of Westmorland allocated for Bikeways and Pedestrian facilities in the following amounts:

FY 2022-23 – TCA/LTF – ARTICLE 3	\$11,268.00
TOTAL	\$36,185.00
